PROJECT TITLE AND SHORT DESCRIPTION

Climate Change and New Exoduses: Understanding Climate Migrants in Portugal

This project intends to understand the relationship between climate change and human mobility, with a specific focus on the phenomenon of climate-induced displacement in Portugal. As climate-related events such as heat waves, droughts, wildfires, floods, and storms become more frequent and intense, they increasingly drive individuals and communities to migrate, either temporarily or permanently. Despite the growing recognition of this issue, the concepts of "climate migrants," "environmental refugees," and "social exclusion" remain subject to debate, with overlapping definitions and interpretations. This study aims to clarify these concepts, providing a clear and comprehensive understanding of the different categories of climate-induced migration. The project will begin by conducting an extensive literature review to map existing knowledge on climate migration and refine the conceptual framework. It will then identify the regions in Portugal most vulnerable to climate-related risks, using statistical data and geographic information to highlight areas of high exposure. This mapping exercise will help determine the regions most likely to generate or receive climate migrants. In addition to quantitative analysis, the project will adopt a qualitative approach, collecting life stories and testimonies from individuals directly affected by climate-induced displacement. These personal narratives will offer a human perspective on the lived experiences of climate migrants, shedding light on their motivations, challenges, coping strategies, and aspirations. The project will also explore the socio-economic and legal dimensions of climate migration, examining the availability of social protection measures, the effectiveness of existing policies, and the potential for discrimination and social exclusion faced by climate migrants. Special attention will be paid to the most vulnerable groups, including women, children, elderly individuals, and low-income households, who may be disproportionately affected by climate-related displacement. This project aims to generate actionable knowledge to inform social policies and enhance social protection mechanisms for climate migrants in Portugal. By bridging the gap between scientific research, public awareness, and policy development, the project seeks to ensure that the issue of climate migration is integrated into the public and political agenda, promoting more resilient and inclusive communities.
